

LABCYTE END USER LICENSE AGREEMENT (“EULA”)

This EULA is between Labcyte Inc. (“Labcyte”) with offices located at 1190 Borregas Ave., Sunnyvale, CA 94089 and the company or individual purchasing or using the software described herein (“Licensee”). The Effective Date of this EULA shall be the date on which the hardware or accompanying software are received by Licensee.

BY USING, RUNNING, OR ACCESSING THE PROGRAMS REFERENCED IN AND ACCOMPANYING THIS EULA, YOU ACCEPT AND AGREE TO THE FOLLOWING TERMS AND CONDITIONS CONTAINED HEREIN. IF YOU DO NOT ACCEPT THESE TERMS, PROMPTLY RETURN THE SOFTWARE TO LABCYTE OR THE DISTRIBUTOR YOU PURCHASED THE SOFTWARE FROM FOR A REFUND OF YOUR PURCHASE PRICE.

1. DEFINITIONS

1.1 The following terms, when used in this EULA shall have the following meanings:

“Documentation” means the documentation or manuals for the Software or System, which may be made available by Labcyte to its Software licensees, whether in written or electronic form.

“Software” refers to software distributed with and for the System and received by Licensee with this EULA and includes any subsequent upgrades or modifications to, or Versions of, the Software provided to Licensee. The Software is developed by Labcyte and installed by Labcyte on any System sold to Licensee. “Software” does not include any Third Party Software (as defined in Section 2.4 of this EULA).

“System” refers to Labcyte’s proprietary liquid handling system and durable components thereof purchased, or otherwise provided under agreement with Labcyte or a distributor, as applicable by the Licensee, and which contains the Software.

“Version” refers to a release of the Software, Documentation, or both. In general, a Version will be designated by a release number that consists of a series of digits separated by a decimal point, e.g., 1.00. Different release numbers denote different Versions.

2. SOFTWARE LICENSE

2.1 License Grant. Subject to the terms and conditions of this EULA, Labcyte grants to Licensee a non-exclusive, non-transferable, limited license to use the Software, solely in machine-readable, object code form, and the related Documentation, subject to the following:

- a. The Software shall be used only by Licensee’s employees and consultants and only for Licensee’s internal research and development purposes (the “Field”).
- b. Licensee shall use, run, or operate the Software only on the System. In addition, Licensee is authorized to use, run, and operate a single copy of the Software on one Licensee computer meeting the requirements set forth in the Documentation.
- c. Licensee shall use the Software only in accordance with its Documentation.

2.2 Licensee Limitations. Licensee will not:

- a. copy, display, transfer, adapt, modify or distribute the Software, electronically or otherwise, except as permitted in Section 2.1 of this EULA;
- b. reverse assemble, reverse compile or otherwise translate the Software except that this limitation will not apply to the extent that such restriction is expressly prohibited by law;
- c. transfer, distribute, sell, resell, lease, sublease, license, sub-license or assign the Software or the license granted by this EULA or otherwise offer the Software for use on a service bureau or outsourced basis; or
- d. remove any copyright, trademark or other proprietary notices of Labcyte or its suppliers or resellers affixed to or displayed on the System, the Software or the Documentation.

2.3 No Implied License. Licensee acknowledges and agrees that this EULA in no way shall be construed to provide to Licensee, or any third party, any express or implied license to use, copy or otherwise exploit the Software or any portion thereof, (including any intellectual property embodied therein) except as expressly set forth in Section 2.1.

2.4 Third Party Software. The Software licensed pursuant to this EULA may be accompanied by certain so-called “open source” software and other third-party software applications or portions of applications, including, without limitation, interfaces, functions, and class definitions (“Third Party Software”), which are provided concurrently with the Software but which are subject to separate terms and conditions (“Third Party Terms”). Exhibit A indicates for all Third Party Software the Third Party Terms under which the Third Party Software is licensed to Labcyte. The Software may interoperate with or require the concurrent installation of this Third Party Software. However, except as stated in this Section 2.4, the Third Party Software is not subject to the terms and conditions of this EULA or the license granted hereby. Licensee hereby acknowledges and agrees that (i) if Licensee uses the Third Party Software, the terms and conditions of any such use are solely between Licensee and the applicable third party, (ii) Labcyte has no obligation or liability with respect to Third Party Software under this EULA, and (iii) Licensee will not (and will not permit or encourage any third party to) use Third Party Software in a manner that would require Software (or any portion thereof) to be distributed or made available free of charge, in source code form, under any Third Party Terms. ANY AND ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE THIRD PARTY SOFTWARE.

3. RESTRICTED USE

3.1 The sale of the System includes a limited, nontransferable, nonexclusive, non-sublicenseable license from Labcyte to Licensee, under U.S. Patents 6,416,164, 6,548,308, 6,603,118 and 6,612,686 and any foreign counterparts thereto and other patents pending or owned by Labcyte (collectively, "Labcyte Technology") solely to use Systems to practice liquid transfers and related process described in such patents solely in the Field. Except as set forth in this Section 3.1, Labcyte does not grant any right or license hereunder to, and Licensee agrees not to make, any commercial use of the Labcyte Technology including without limitation, use of the Labcyte Technology to (i) manufacture physical products for external sale, (ii) provide diagnostic services or (iii) perform any of the foregoing on behalf of any third party.

4. OWNERSHIP

4.1 Labcyte's Ownership Rights. Except for the licenses granted hereunder, all rights, title and interests, including, but not limited to, all worldwide patent, copyright, trademark, trade secret and any other rights in and to the Software, the Documentation and the Systems are retained by Labcyte and its licensors. Licensee agrees that it shall not do, or cause to be done, any acts or things contesting or in any way impairing or tending to impair any portion of the right, title and interest of Labcyte or its licensors in and to such intellectual property rights.

The Deerac Fluidics, Echo, Labcyte, Microlime, Portrait, Deerac and POD trademarks are the property of Labcyte and may not be used without express, written permission.

5. **DISCLAIMER.** Any warranties with respect to the Software, Documentation or Systems shall be as set forth in Labcyte's Terms and Conditions of Sale or in a separate written agreement between you and the distributor from whom you purchased the System, as applicable. LABCYTE DISCLAIMS ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, NON-INFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE. Some jurisdictions do not allow or otherwise govern the scope of exclusions of implied warranties so the above exclusions may not apply in full.

6. INDEMNIFICATION

6.1 Infringement.

6.1.1 Defense. In the event of a claim against Licensee for the infringement or misappropriation of a third party United States or European copyright, patent or trademark by reason of the use by Licensee of the Software as permitted hereunder, Labcyte may elect to defend and settle such claim, and pay reasonable costs and expenses and finally awarded damages actually awarded in connection therewith, including the

reasonable fees and expenses of the attorneys engaged by Labcyte for such defense provided that (i) Licensee shall promptly notify Labcyte of such claim, (ii) Labcyte shall have the sole and exclusive authority to defend and/or settle any such claim and (iii) Licensee reasonably cooperates with Labcyte in connection therewith.

6.1.2 Actions in Response to Potential Infringement. If the use of the Software by Licensee has become, or in Labcyte's opinion is likely to become, the subject of any claim of infringement, Labcyte may at its option and expense (i) procure for Licensee the right to continue using the Software as set forth hereunder, (ii) replace or modify the Software to make it non-infringing, (iii) substitute an equivalent for the Software or, if options (i)-(iii) are not reasonably practicable, (iv) terminate this EULA.

6.1.3 Limitation on Infringement Indemnification. Labcyte shall have no liability or obligation under Section 6.1.1 or Section 6.1.2 with respect to any claim if such claim is caused in whole or in part by (i) compliance with designs, guidelines, plans or specifications of Licensee; (ii) use of the Software by Licensee in an application or environment other than as specified in applicable Documentation or outside of the Field; (iii) modification of the Software by any party other than Labcyte; or (iv) the combination, operation or use of the Software with other applications, portions of applications, product(s) or services where the Software would not by itself be infringing. Licensee agrees to indemnify, defend and hold harmless Labcyte from and against all liabilities, obligations, costs, expenses and judgments, including court costs, reasonable attorneys fees and expert fees, arising out of any of the circumstances stated in subsections (i) - (iv) above. THIS ARTICLE 6 STATES LABCYTE'S ENTIRE AND EXCLUSIVE LIABILITY AND OBLIGATION, AND LICENSEE'S EXCLUSIVE REMEDY (AT LAW OR IN EQUITY), WHETHER STATUTORY, CONTRACTUAL, EXPRESS, IMPLIED OR OTHERWISE, FOR ANY CLAIM OF ANY NATURE RELATED TO INFRINGEMENT OR MISAPPROPRIATION OF INTELLECTUAL PROPERTY.

6.2 Indemnification by Licensee. Licensee shall indemnify, defend and hold harmless Labcyte against any and all claims, damages, losses, liabilities, costs and expenses (including reasonable attorney's fees) directly or indirectly brought against Labcyte by any third party arising out of Licensee's use of the Software in violation of the terms of this EULA, including for any use outside of the Field or not on System, or in a manner not prescribed in the Documentation.

7. **LIMITATION OF LIABILITY.** UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY, WHETHER IN TORT (INCLUDING NEGLIGENCE AND STRICT LIABILITY), CONTRACT, OR OTHERWISE, SHALL LABCYTE BE LIABLE TO LICENSEE OR ANY OTHER PERSON OR ENTITY FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES OF ANY CHARACTER, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF GOODWILL, LOST PROFITS, LOST SALES OR BUSINESS, WORK STOPPAGE, COMPUTER FAILURE OR MALFUNCTION, LOST DATA, OR FOR ANY AND ALL OTHER DAMAGES OR LOSSES, EVEN IF A REPRESENTATIVE OF LABCYTE HAS BEEN ADVISED, KNEW OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL LABCYTE'S

TOTAL LIABILITY TO LICENSEE OR ANY OTHER THIRD PARTY OR ENTITY FOR DAMAGES IN ANY ONE OR MORE CAUSE(S) OF ACTION EXCEED THE AMOUNT PAID BY LICENSEE FOR THE SYSTEM. THE PROVISIONS OF THIS SECTION ALLOCATE THE RISKS UNDER THIS EULA BETWEEN THE PARTIES, AND THE PARTIES HAVE RELIED ON THE LIMITATIONS SET FORTH HEREIN IN DETERMINING WHETHER TO ENTER INTO THIS EULA. Some jurisdictions restrict the limitation of liability or damages so the above exclusions and limitations may not apply.

8. TERMINATION

8.1 Term. The term of this EULA shall commence on the Effective Date and continue so long as the terms and conditions of this EULA are satisfied unless terminated by either party as provided herein.

8.2 Termination. Labcyte may terminate this EULA immediately in the event of a breach by Licensee of its obligations hereunder.

8.3 Licensee Obligations on Termination. Upon termination of this EULA all licenses granted hereunder shall immediately terminate and Licensee shall destroy or return to Labcyte all Software and the Documentation, in its possession or control. Termination of this EULA shall not relieve Licensee from paying all fees accruing prior to termination. Sections 2.2, 2.3, 2.4, 8.3 and Articles 1, 3, 4, 5, 6, 7 and 9 shall survive the termination or expiration of this EULA.

9. GENERAL

9.1 Compliance. Licensee shall, at its own expense, be responsible for current and ongoing familiarity with, and shall at all times comply with all applicable laws, treaties, rules, regulations, orders and other requirements relating to this EULA. Without limiting the generality of the foregoing, Licensee shall not transfer, either directly or indirectly, the Software or the Documentation, either in whole or in part, to any destination subject to export restrictions under United States law, unless prior written authorization is obtained from the appropriate United States agency and shall otherwise comply with all other applicable import and export laws, rules and regulations.

9.2 Publicity. Licensee shall not make any public statements including, without limitation, press releases or public announcements regarding the Software or this EULA.

9.3 Assignment by Licensee. Licensee may not assign this EULA (or any of its rights hereunder), or delegate its obligations hereunder to any other party except in connection with the transfer of System provided that any such assignee agrees in writing to be bound by the terms of this EULA. For purposes of this section, assignments shall include assignments by operation of law, including without limitation, merger and acquisition.

9.4 Amendment; Waiver. No amendment or modification to this EULA, nor any waiver of any rights hereunder, shall be effective unless assented to in writing by both parties. The waiver of any breach or default or failure by Labcyte to enforce any provision shall not constitute a waiver of such provision, any other right hereunder or any subsequent breach or default.

9.5 Relationship. Nothing contained herein shall in any way constitute any association, partnership, agency, employment or joint venture between the parties hereto, or be construed to evidence the intention of the parties to establish any such relationship.

9.6 Unenforceability. If a court of competent jurisdiction determines that any provision of this EULA is invalid, illegal, or otherwise unenforceable, such provision shall be enforced as nearly as possible in accordance with the stated intention of the parties, while the remainder of this EULA shall remain in full force and effect and bind the parties according to its terms. To the extent any provision cannot be enforced in accordance with the stated intentions of the parties, such provision shall be deemed not to be a part of this EULA.

9.7 Governing Law. This EULA shall be governed by the laws of the State of California, United States, exclusive of its rules governing choice of law and conflict of laws. This EULA shall not be governed by the 1980 United Nations Convention on Contracts for the International Sale of Goods. All disputes arising out of the EULA shall be subject to the exclusive jurisdiction and venue of the courts of Santa Clara County, California, and the parties to this EULA hereby consent to the personal jurisdiction of these courts.

9.8 Notices. Any notice required or permitted to be given hereunder shall be given in writing to the party at the address specified in this EULA by personal delivery, certified mail, return receipt requested, or by overnight delivery.

9.9 Audit. Labcyte or its authorized representative or Labcyte's licensors or their authorized representatives shall have the right, upon reasonable advance notice, to audit and inspect information regarding Licensee's use of the Software, Documentation and Systems in order to verify compliance with the terms of this EULA.

9.10 Entire EULA. This EULA comprises the entire agreement between Licensee and Labcyte with respect to its subject matter, and supersedes all prior and contemporaneous proposals, statements and agreements (oral and written). In the event of any conflict between this EULA and any click through agreements accompanying the System, this EULA shall control. No oral or written information or advice given by Labcyte, its agents or employees shall create a warranty or in any way increase the scope of the warranties in this EULA.

9.11 Titles. All article and section titles herein are provided for general information and reference only. Thus, the subject matter in each section herein shall not be construed by reference to the title nor shall the scope of section be limited in any manner based on the title of that section.

Preamble

GNU LESSER GENERAL PUBLIC LICENSE TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

This License Agreement applies to any software library or other program which contains a notice placed by the copyright holder or other authorized party saying it may be distributed under the terms of this Lesser General Public License (also called "this License"). Each licensee is addressed as "you".

A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

The "Library", below, refers to any such software library or work which has been distributed under these terms. A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. (Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it. For a library, complete source code means all the source code for all modules it contains, plus any associated interface definition files, plus the scripts used to control compilation and installation of the library.

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running a program using the Library is not restricted, and output from such a program is covered only if its contents constitute a work based on the Library (independent of the use of the Library in a tool for writing it). Whether that is true depends on what the Library does and what the program that uses the Library does.

1. You may copy and distribute verbatim copies of the Library's complete source code as you receive it, in any medium, provided that you conspicuously and appropriately publish on each copy an appropriate copyright notice and disclaimer of warranty; keep intact all the notices that refer to this License and to the absence of any warranty; and distribute a copy of this License along with the Library.

You may charge a fee for the physical act of transferring a copy, and you may at your option offer warranty protection in exchange for a fee.

2. You may modify your copy or copies of the Library or any portion of it, thus forming a work based on the Library, and copy and distribute such modifications or work under the terms of Section 1 above, provided that you also meet all of these conditions:

- a) The modified work must itself be a software library.
- b) You must cause the files modified to carry prominent notices stating that you changed the files and the date of any change.

c) You must cause the whole of the work to be licensed at no charge to all third parties under the terms of this License.

d) If a facility in the modified Library refers to a function or a table of data to be supplied by an application program that uses the facility, other than as an argument passed when the facility is invoked, then you must make a good faith effort to ensure that, in the event an application does not supply such function or table, the facility still operates, and performs whatever part of its purpose remains meaningful.

(For example, a function in a library to compute square roots has a purpose that is entirely well-defined independent of the application. Therefore, Subsection 2d requires that any application-supplied function or table used by this function must be optional: if the application does not supply it, the square root function must still compute square roots.)

These requirements apply to the modified work as a whole. If identifiable sections of that work are not derived from the Library, and can be reasonably considered independent and separate works in themselves, then this License, and its terms, do not apply to those sections when you distribute them as separate works. But when you distribute the same sections as part of a whole which is a work based on the Library, the distribution of the whole must be on the terms of this License, whose permissions for other licensees extend to the entire whole, and thus to each and every part regardless of who wrote it.

Thus, it is not the intent of this section to claim rights or contest your rights to work written entirely by you; rather, the intent is to exercise the right to control the distribution of derivative or collective works based on the Library. In addition, mere aggregation of another work not based on the Library with the Library (or with a work based on the Library) on a volume of a storage or distribution medium does not bring the other work under the scope of this License.

3. You may opt to apply the terms of the ordinary GNU General Public License instead of this License to a given copy of the Library. To do this, you must alter all the notices that refer to this License, so that they refer to the ordinary GNU General Public License, version 2, instead of to this License. If distribution of object code is made by offering access to copy from a designated place, then offering equivalent access to copy the source code from the same place satisfies the requirement to distribute the source code, even though third parties are not compelled to copy the source along with the object code.

5. A program that contains no derivative of any portion of the Library, but is designed to work with the Library by being compiled or linked with it, is called a "work that uses the Library". Such a work, in isolation, is not a derivative work of the Library, and therefore falls outside the scope of this License.

However, linking a "work that uses the Library" with the Library creates an executable that is a derivative of the Library (because it contains portions of the Library), rather than a "work that uses the library". The executable is therefore covered by this License. Section 6 states terms for distribution of such executables.

When a "work that uses the Library" uses material from a header file that is part of the Library, the object code for the work may be a derivative work of the Library even though the source code is not. Whether this is true is especially significant if the work can be linked without the Library, or if the work is itself a library. The threshold for this to be true is not precisely defined by law.

If such an object file uses only numerical parameters, data structure layouts and accessors, and small macros and small inline functions (ten lines or less in length), then the use of the object file is unrestricted, regardless of whether it is legally a derivative work. (Executables containing this object code plus portions of the Library will still fall under Section 6.)

Otherwise, if the work is a derivative of the Library, you may distribute the object code for the work under the terms of Section 6.

Any executables containing that work also fall under Section 6, whether or not they are linked directly with the Library itself.

6. As an exception to the Sections above, you may also combine or link a "work that uses the Library" with the Library to produce a work containing portions of the Library, and distribute that work under terms of your choice, provided that the terms permit modification of the work for the customer's own use and reverse engineering for debugging such modifications.

You must give prominent notice with each copy of the work that the Library is used in it and that the Library and its use are covered by this License. You must supply a copy of this License. If the work during execution displays copyright notices, you must include the copyright notice for the Library among them, as well as a reference directing the user to the copy of this License. Also, you must do one of these things:

a) Accompany the work with the complete corresponding machine-readable source code for the Library including whatever changes were used in the work (which must be distributed under Sections 1 and 2 above); and, if the work is an executable linked with the Library, with the complete machine-readable "work that uses the Library", as object code and/or source code, so that the user can modify the Library and then relink to produce a modified executable containing the modified Library. (It is understood that the user who changes the contents of definitions files in the Library will not necessarily be able to recompile the application to use the modified definitions.)

b) Use a suitable shared library mechanism for linking with the Library. A suitable mechanism is one that (1) uses at run time a copy of the library already present on the user's computer system, rather than copying library functions into the executable, and (2) will operate properly with a modified version of the library, if the user installs one, as long as the modified version is interface-compatible with the version that the work was made with.

c) Accompany the work with a written offer, valid for at least three years, to give the same user the materials specified in Subsection 6a, above, for a charge no more than the cost of performing this distribution.

d) If distribution of the work is made by offering access to copy from a designated place, offer equivalent access to copy the above specified materials from the same place.

e) Verify that the user has already received a copy of these materials or that you have already sent this user a copy.

For an executable, the required form of the "work that uses the Library" must include any data and utility programs needed for reproducing the executable from it. However, as a special exception, the materials to be distributed need not include anything that is normally distributed (in either source or binary form) with the major components (compiler, kernel, and so on) of the operating system on which the executable runs, unless that component itself accompanies the executable.

It may happen that this requirement contradicts the license restrictions of other proprietary libraries that do not normally accompany the operating system. Such a contradiction means you cannot use both them and the Library together in an executable that you distribute.

7. You may place library facilities that are a work based on the Library side-by-side in a single library together with other library facilities not covered by this License, and distribute such a combined library, provided that the separate distribution of the work based on the Library and of the other library facilities is otherwise permitted, and provided that you do these two things:

These actions are prohibited by law if you do not accept this License. Therefore, by modifying or distributing the Library (or any work based on the Library), you indicate your acceptance of this License to do so, and all its terms and conditions for copying, distributing or modifying the Library or works based on it.

10. Each time you redistribute the Library (or any work based on the Library), the recipient automatically receives a license from the original licensor to copy, distribute, link with or modify the Library subject to these terms and conditions. You may not impose any further restrictions on the recipients' exercise of the rights granted herein. You are not responsible for enforcing compliance by third parties with this License.

11. If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. For example, if a patent license would not permit royalty-free redistribution of the Library by all those who receive copies directly or indirectly through you, then the only way you could satisfy both it and this License would be to refrain entirely from distribution of the Library.

This section is intended to make thoroughly clear what is believed to be a consequence of the rest of this License.

If the distribution and/or use of the Library is restricted in certain countries either by patents or by copyrighted interfaces, the original copyright holder who places the Library under this License may add an explicit geographical distribution limitation excluding those countries, so that distribution is permitted only in or among

countries not thus excluded. In such case, this License incorporates the limitation as if written in the body of this License.

13. The Free Software Foundation may publish revised and/or new versions of the Lesser General Public License from time to time.

Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns. Each version is given a distinguishing version number. If the Library specifies a version number of this License which applies to it and "any later version", you have the option of following the terms and conditions either of that version or of any later version published by the Free Software Foundation. If the Library does not specify a license version number, you may choose any version ever published by the Free Software Foundation.

14. If you wish to incorporate parts of the Library into other free programs whose distribution conditions are incompatible with these, write to the author to ask for permission. Our decision will be guided by the two goals of preserving the free status of all derivatives of our free software and of promoting the sharing and reuse of software generally.

EXCEPT WHEN OTHERWISE STATED IN WRITING THE COPYRIGHT HOLDERS AND/OR OTHER PARTIES PROVIDE THE LIBRARY "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE LIBRARY IS WITH YOU. SHOULD THE LIBRARY PROVE DEFECTIVE, YOU ASSUME THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

16. IN NO EVENT UNLESS REQUIRED BY APPLICABLE LAW OR AGREED TO IN WRITING WILL ANY COPYRIGHT HOLDER, OR ANY OTHER PARTY WHO MAY MODIFY AND/OR REDISTRIBUTE THE LIBRARY AS PERMITTED ABOVE, BE LIABLE TO YOU FOR DAMAGES, INCLUDING ANY GENERAL, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE THE LIBRARY (INCLUDING BUT NOT LIMITED TO LOSS OF DATA OR DATA BEING RENDERED INACCURATE OR LOSSES SUSTAINED BY YOU OR THIRD PARTIES OR A FAILURE OF THE LIBRARY TO OPERATE WITH ANY OTHER SOFTWARE), EVEN IF SUCH HOLDER OR OTHER PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
